Interview

From 12nd to 14th November 2019, Nairobi hosted a summit to mark 25 years since the landmark International Conference on Population and Development (ICPD), which recognized that reproductive health, women's empowerment and gender equality are critical to sustainable development. Patrizia Farina was invited to be part of the Italian delegation as expert on female genital mutilation. The United Nations General Assembly has designated November 25 as the International Day for the Elimination of Violence Against Women (Resolution 54/134). Issue 2/2019 of the newsletter starts with an interview with Patrizia Farina also with the aim of celebrating this day.

Patrizia Farina: the issue of women sexual and reproductive health



Patrizia FARINA is Full Professor of Demography at the Department of Sociology and Social Research, University of Milano-Bicocca. After completing her MA/BA she attended a specialization course in Chinese language at the Foreign language University of Beijing. In 1994 she completed the PhD in Demography at University La Sapienza of Roma. She has been member of the Board of the National Institute of Statistics, and member of SISTAN until last June. She is member of national and

international organizations and serves as reviewer for several scientific journals.

Looking at your publications, you have at least two fields of research...

It is right. China has long been my main interest and even now, I published articles on China to addressing the original demographic transition that this country has offered, and the challenge it still offers. Particularly, I focused my research on birth control policies carried first on a voluntary then following coercive approaches. Now I am very interested in studying whether and how the Chinese Government will be able to implement the New Population Policy the "Two-child", going to the opposite direction compare the past 30 years of strict reduction of natality.

Your interest for Chinese population isn't closed within Chinese borders...

I have also dealt with the Chinese migration in Italy. Some colleagues and I wrote a book that traces the history of the community established in Milan from the end of the First World War to the mid-1990s. I occasionally returned to reflect on Chinese community settlement and its change. Nowadays the Chinese migrants are an economically stratified group as is the Italian society, it maintains a strong identity but the solidarity networks – probably the most distinctive trait of the first generation of Chinese migrants – have weakened.

You are the coordinator of the most recent summer school in China for students of our University. What is the purpose of this initiative?

The main task of the summer school, organized with the financial support of the Department of Sociology and Social Research, is to help students understanding a huge country of growing importance in the world. The knowledge of our students often does not cross the European Borders. China is something far from their understanding unless they came across Chinese and migrant population. Two weeks represent a short period, but that is a fruitful experience for our students, a starting point to increase interests for this country. Actually, from two editions at least one of participant has planned to study in China for a period. One is now in Chengdu at Interclub Academy; another will leave soon to Hangzhou University for a course of specialization in psychology.

Your research has also developed around the issue of the sexual and reproductive health.

Yes, this is the most recent and even most important area of my research, strictly connected to gender-based violence. In the field of sexual and reproductive health, I deal with female genital mutilation (FGM), a traditional practice that includes all procedures that intentionally alter female genital organs for non-medical reasons. The practice affects 200 million girls and woman living predominantly in African countries, Yemen, Iraq and Indonesia. It can cause short- and long-term health complications, increase risk of HIV transmission, depression, birth complications, infertility and, in the worst cases, death. The reasons why female genital mutilations are performed include a mix of factors within families and communities. In general, FGM is often considered part of raising a girl, and a way to prepare her for adulthood and marriage. Besides, FGM aims to ensure premarital virginity and marital fidelity. It is associated with cultural ideals of femininity and modesty, which include the notion that girls are clean and beautiful after the removal of body parts considered unclean and unfeminine. That is why the issue is rooted in the gender-based discrimination.

Which are the main trends in female genital mutilation that you have been studying?

For what concerns the global picture, decades of actions of international agencies, governments, civil society, communities, and individuals accelerated the secular decline of FGM. Also, among migrant population the tendency to abandon the practice is clear. However, the social norms that

support the practice are still widespread, especially among less educated and more segregated people. Therefore, we need to reinforce the movement that starts from women, engaging stakeholders, religious leaders and anyone who has a word that matters in the community. Many researches published in recent years also suggested that the empowerment of women could accelerate the abandon of such habits.

You mention migrations. Is FGM widespread in Italy, too?

The feminization of African migration flows to Italy led to an increased presence of women with FGM. We do need to know how many mutilated female migrants live in Italy, which kind of mutilation they are affected, how much they support the practice to set appropriate health assistance and policies to protect girls. To this aim several projects tried to estimate the prevalence of women and girls with FGM in Italy, the last of which have been granted this year by the Department of Equal opportunity of the Italian government. We'll present the results in the next months.

Recently you have attended the Nairobi+25 United Nations Summit as member of the Italian delegation...

I have been invited to be part of the Italian delegation as expert on FGM. The Conference of Nairobi organized by UNFPA had a special meaning. This year marks the 25th anniversary of the International Conference on Population and Development in Cairo, where the Programme of Action, which set out to empower women and girls for their sake, was adopted. Since then the progress has been remarkable, but too many women and girls are still "left behind". Over 9,000 participants from 170 countries came with a shared purpose to "accelerate the promise of 1994". By the end of the Nairobi Conference, over 1,250 commitments were made by governments, including Italy, donors, businesses, non-governmental organizations, civil society and other actors to support the goals called the "three zeros": zero maternal mortality, zero unmet needs for family planning and zero tolerance towards gender-based violence, including FGM and early marriage. It has been a great honor for me to participate at the Conference. Above all, learning from people engaged every day on issues that I teach in the "comfort zone" of the classroom has made me more aware of the subjects of my teaching.

Can we trust data collected using web surveys? Assessing the quality of an Italian non-probability online panel

Abstract: This thesis sits in the survey-methodology field and explores the challenging concept of data quality when using online panels as a sample source in the survey industry. Over time, sample surveys implemented different techniques to overcome various challenges. In particular, high costs, need for timely data delivery, and under-coverage (in the case of telephone surveys) are the main drivers of the development of online panels in survey research, from the 1990s on. Online panels are large pools of registered people who agreed to take part in web-based research in exchange for some form of incentive. They have the advantages of: i) reducing both costs and time devoted to data collection and delivery, and ii) providing a sampling frame of registered individuals who consented to participate in surveys. The main objective of this thesis is to empirically assess the quality of primary data collected from an Italian non-probability online-panel survey, comparing the estimates obtained from this web survey to those obtained from a probability-based survey conducted by the Italian National Institute of Statistics (ISTAT), used as benchmarks. In particular, the thesis is focused on: i) under-coverage and self-selection bias in different samples (i.e., the Internet population, panel members, and web survey respondents), ii) nonresponse bias, comparing the characteristics of web survey respondents to those of non-respondents, iii) data quality, comparing the estimates obtained from the web survey to those obtained from a probability-based reference survey, and iv) a weighting adjustment to remove bias.

YOUNG TALENTS AWARD

Alessandra Gaia, Research Fellow at the Department of Sociology and Social Research, has been awarded with the third place at the 2019 edition of the Young Talents Prize (Premio Giovani Talenti dell'Università degli Studi di Milano-Bicocca). SUMMER SCHOOL "RETHINKING THE CULTURE OF TOLERANCE" EUROPEAN INTEGRATION AFTER THE FALL OF THE BERLIN WALL

Sarajevo, East Sarajevo and Mostar, 16-22 September 2019

The International Summer School "Rethinking the Culture of Tolerance", as a joint program of the University of Milan-Bicocca, the University of Sarajevo and the University of East Sarajevo, started its second three-year cycle in September 2017.

The sixth edition of the School, titled "European integration after the fall of the Berlin wall", organized in cooperation with the University of Milano, the University of Mostar and the "Džemal Bijedić" University of Mostar, took place in September 2019 at the University of Sarajevo, Center for Interdisciplinary Studies. Dedicated to the thirtieth anniversary of the revolutionary year 1989,



the School examined problems and contradictions faced by the evolving European societies, with a focus on the post-communist countries involved in the process of EU integration over the past three decades.

Twenty-four lecturers and thirty participants came from sixteen different countries: Bosnia and Herzegovina, Italy, Slovenia, Serbia, North Macedonia, Kosovo, Albania, Germany, Belgium, United Kingdom, Denmark, Portugal, Poland, Russian Federation, India and Iraq. Two public artistic events - "RISE AND FALL", Multimedial exhibition by Jim Marshall and Matteo Ceschi, and "AWAKENING", Art mural composed by Rikardo Druškić - were organised by the Summer School in cooperation with the EU Info Center in Sarajevo and the Historical museum of B&H, enhancing the visibility and outreach of the project.

The Embassy of the Republic of Italy in Bosnia-Herzegovina supported the School with the Patronage for the sixth time, with the particular commitment of the Ambassador H.E. Nicola Minasi. Special
